#### **ENTRY REQUIREMENTS**

#### Local

- Bachelor Degree with honours with a minimum Cumulative Grade Point Average (CGPA) 2.75 from UTHM or any institution of higher learning recognized by the Senate with a minimum of three (3) years working experience; or
- Bachelor Degree with a minimum CGPA 3.00 from UTHM or any institution of higher learning recognized by the Senate and without working experience.

#### International

 All International applicants shall meet the English entry requirement, which is either with a minimum IELTS score of 6.0. or TOEFL score of 550. An exception shall only be given to those applicants who received a bachelor's degree from a university where English is the sole language instruction.

\*Application from applicant who possess a Bachelor Degree or equivalent not meeting the minimum CPA can be accepted subjected to minimum years of working experience in related field.

\*(ONE (1) year working experience equivalence to 0.1 CPA)
